

URGENT – ONE WEEK TO GO: How to respond online

To comment on sites MX52/53 Corinthians and Banckside, which have been excluded from the plan

and scroll down to Policy ST2 – Housing and Mixed Use Allocations.

You then need to scroll down, past the mauve section, and click the ‘add a comment’ box for Policy ST2.

You will be asked to log in or register. If you have already commented online during the previous or current consultations then use the login details you created then. If not, you will need to register now.

Complete the form which opens up:

If you agree that MX52/53 should not be included in the Local Plan, answer ‘yes’ to each question.

ST2 – 39: The Forge, Ash Road, New Ash Green

ST2 – 40: Oast House Nursery, Ash Road, Ash

ST2 – 52: Fawkham Business Park, Fawkham Road, Fawkham

ST2 – 53: Grange Park Farm, Manor Lane, Fawkham

For each site, click the ‘add a comment’ box at the foot of that site’s entry.

The first time you do this you will be asked to log in or register. If you have already commented online during the previous or current consultations then use the login details you created then. If not, you will need to register now.

The same form will be presented for each site. Answer the questions about whether you think the Plan is sound etc as you see fit. These apply to the Plan as a whole, not to any one site.

In the ‘Modifications’ box, please suggest what you’d like to see changed.
